The Centre had a closing cash balance of \$83,014 as at 31 December 2022 in our general bank account.

The Centre registration fees this year were increased for the first time in 5 years, as a result of Athletics West increasing their affiliation fees.

Some of the significant capital items purchased or constructed during the year were as follows:

The Centre also has ~\$28.5k in a separate investment account for use at a later date. It remains the current Committee's intention to use these monies for major capital / equipment purchases and not for the day to day running costs of the Centre.

The Centre is in a sound financial position and will continue to focus on the needs of our athletes when it comes to capital expenditure.

As a committee we are constantly striving to make the Centre better each year, and it is important that we continue to provide fantastic coaches, equipment and facilities to our wonderful athletes.
